



## ***ABRA Update #151 – October 12, 2017***

### **Additional Information Provided on Virginia DEQ Water Quality Meetings**

Last week's ABRA Update reported that the Virginia State Water Control Board would hold special meetings in on the proposed water quality certifications for the Atlantic Coast Pipeline (ACP) and Mountain Valley Pipeline (MVP). The Department of Environmental Quality has since provided additional information on how the sessions will proceed.

*At each meeting, the Virginia Department of Environmental Quality will present a summary of the public comments it received and will make its recommendations to the board on the proposed conditions. At each meeting, the board may approve, deny or amend the recommendations.*

*The meeting dates are: MVP - December 6 & 7, 2017; ACP – December 11 & 12, 2017*

- *Each meeting will start at 9:30 a.m. and is scheduled to last up to two days.*
- *On the first day of each meeting, those persons who made oral or written comments may sign up to respond to the summary of public comments presented to the board by DEQ.*
- *The meeting is open to the public.*
- *Under the board's [policy](#), only those people who provided comments during the July 3, 2017 – August 22, 2017 official public comment period may speak to the board.*
- *The response document will be available on the DEQ website in advance of the December meetings.*

## ACP/MVP Easement Conversions Top VOF Agenda for Monday

The proposed conservation easement conversions of certain properties along the routes of the Atlantic Coast Pipeline and the Mountain Valley Pipeline may be decided on Monday, October 16 during a special meeting of the Board of Directors of the Virginia Outdoors Foundation. The 10 am meeting will be held at office of the State Corporation Commission, 1300 East Main Street, Richmond, VA 23219

Actions available to the board include approval or disapproval of the conversions, but a decision could be deferred until a later date.

## People's Tribunal Set for October 28 in Charlottesville

A public forum on human rights and environmental justice impacts that would result from the Atlantic Coast Pipeline and the Mountain Valley Pipeline is scheduled for Saturday, October 28 in Charlottesville, VA beginning at 11:30 am. The event will feature experts in the fields of environmental and medical science, environmental justice presiding as judges to hear first-person impacts and expert testimonies from persons in affected communities. Among the more than twenty co-sponsoring organizations are ABRA, Virginia Sierra Club, Friends of Buckingham, Appalachian Voices and Yogaville Environmental Solutions. ## North Carolina Begins ACP Air Permit Consideration

The North Carolina Division of Air Quality on October 10 opened a public comment period for a minor source air quality permit for the proposed Northampton Compressor Station, which would serve the Atlantic Coast Pipeline (ACP). If the permit is approved, it will regulate operation of air emissions sources and air cleaning devices. The [agency's announcement](#) also said that it will hold a public hearing on the draft permit at 6 p.m. Nov. 15 at in Garysburg, N.C.

Commencement of the air permit consideration follows last week's release by another division of the state's Department of Environmental Quality of a [letter of disapproval](#) of the ACP's erosion and sediment plan for the North Carolina portion of the project. This news was communicated to the ABRA mailing list in a special email alert last Friday, October 6.
