### **WV Shirks Its Responsibility, Waives 401 Review for MVP**

West Virginia's Department of Environmental Protection (DEP) [announced November 1](#) that "the state has chosen to waive the individual 401 Certification of the federal permits for the Mountain Valley Pipeline. The Army Corps of Engineers recently reissued, with provisions that are specific to West Virginia, the Nationwide 12 permit which is used for stream crossings. These new conditions, when combined with specific requirements that are included in the state's storm water permit, will allow for better enforcement capabilities and enhanced protection for the state's waters."

In response to the DEP announcement, several environmental and conservation groups [called the agency's action a "dereliction of duty."](#) Angie Rosser, Executive Director of the West Virginia Rivers Coalition, noted that "DEP is a taxpayer-supported agency whose job is to protect public health and the environment. It appears that political favor to industry has won the day over the agency's responsibility to do everything in its power to protect the public's right to clean water."

Anne Havemann, General Counsel of the Chesapeake Climate Action Network, said that "West Virginia's decision to waive its right to protect hundreds of streams and rivers from MVP is a complete abdication of its duty and an irreparable breach of the public's trust."

The POWHR coalition, which is leading the fight against the Mountain Valley Pipeline, also issued a statement: "In light of West Virginia's ill-advised choice today, we want to amplify our call to Virginia's State Water Control Board to exercise every ounce of muscle it has in oversight of the permitting request for the Mountain Valley *and* the Atlantic Coast pipelines and in the full application of the Clean Water Act."

The DEP has not yet announced a decision regarding its Section 401 review of the Atlantic Coast Pipeline.

### **Governor McAuliffe Reaffirms Support for ACP and His Lack of Authority**

Virginia Governor Terry McAuliffe, appearing recently in Bath County at the dedication of a new solar energy facility at a local school, reiterated his strong support for the Atlantic Coast Pipeline, which would desecrate a significant portion of the county. In responding to a reporter's question, he said "as I've always said, first off, it's not the governor's office, it's a FERC (Federal Energy Regulatory Commission) permit, and there are several permits it would go through the state. But that's determined by the General Assembly on the regulations and how they're defined."

## Water Is Life Parade and Rally Planned for December 2 in Richmond

A Water is Life Parade and Rally will be held on Saturday, December 2 in Richmond, VA to bring together the community of organizations and grassroots groups that have been working against the Atlantic Coast (ACP) and Mountain Valley (MVP) pipelines in the interest of protecting Virginia's waters. The event is in anticipation of the planned meetings of the State Water Control Board on December 6 and 7 (for the MVP) and December 11 and 12 (for the ACP) to consider whether to issue water certifications for the respective pipeline projects. ## Advisory Council on Environmental Justice Established in Virginia

Governor Terry McAuliffe announced on October 31 the convening of the Commonwealth of Virginia's first Environmental Justice Advisory Council (EJAC). The EJAC, established by [Executive Order 73](#), will provide advice and recommendations to the Executive Branch on ways in which environmental justice should be incorporated in decision-making. Environmental Justice is the principle that no community or individual should bear disproportionate impacts from pollution.

The Governor said: "This Environmental Justice Advisory Council will work to ensure that every Virginian has a voice in protecting the quality of our air and water. This Council will provide critical advice on how to protect our natural resources and address environmental pollution in a way that is both inclusive and action-oriented."

The issuance of the Governor's Executive Order follows the [October 28 People's Tribunal event in Charlottesville](#), which highlighted environmental justice issues raised by the proposed Atlantic Coast and Mountain Valley pipelines.

## Implementation Plan for the MVP Filed

A 300+ page Implementation Plan (length of the public portion) for the Mountain Valley Pipeline (MVP) was [filed October 31](#) with the Federal Energy Regulatory Commission (FERC). The Plan details how the MVP is to be built. An Implementation Plan for the Atlantic Coast Pipeline was filed with FERC on October 17, [as reported on in last week's ABRA Update](#).
